## A Wild Ride for the City's Neighborhood Councils...and its not over yet

During the week of February 22, three incidences arose that had Neighborhood Councils concerned about the financial status and future of Neighborhood Councils in the City of Los Angeles. Mayor Villaraigosa's press release signaled the merge of the Department of Neighborhood Empowerment (DONE) with the Community Development Department (CDD). The Mayor said the consolidation effort would potentially eliminate 27 positions and save an estimated \$2 million dollars annually. By

July, there would be 16 funded positions for DONE when approved.

Councilmember Greig Smith's motion to immediately remove the City Clerk from the election process and put election funds into the general fund sent shockwaves throughout Neighborhood Councils whose elections would fall within the month of March 2010. Smith said, ""This was a question of simple money. If doing this would help keep Neighborhood Councils funded and put some money back in the general fund, then it would be a winner."

Subsequently, Councilman Paul Krekorian, Chair of the City's Education and Neighborhoods Committee, recommended the City Council oppose the Smith/Rosendahl motion until more discussion could take place. Smith agreed. The next day, the City Council vote on the motion was unanimous as Smith graciously voted with others to reject it.

Questions about the legalities of such a consolidation of the two departments also emerged, causing more anxiety within the neighborhood councils. In his press release, Mayor Villaraigosa said, "The consolidation effort will not only create cost savings, but will

serve to take the bureaucracy out of community empowerment". But City Charter Sec. 913 prohibits Transfer of Powers of DONE to any other department during the first five years pursuant to Section 905.

## **California's Traffic Ticket Fines Increased**

Beware! If you are a driver who has a "lead foot," who is a notorious speeder, who talks on your cell phone that is not "hands free", who texts while driving, who runs stop signs and red lights, or violates other California Motor Vehicle Codes, you are in for "Ticket Shock" after being "written up" by a diligent Traffic Officer. Effective January 6, 2010, motor vehicle fines increased by approximately 30 percent. Non-moving infractions that used to be dismissed, like after showing proof of a valid driver's license or insurance coverage, for instance, now have a "reduced" cost (see chart below).

There was a time when violators were allowed to attend traffic school. Traffic school is a program that allows certain moving violators to receive instruction in driving and traffic safety. At one time, the court could refer you to a Traffic Violators Program, or you could

have requested it. Upon completion of the course, you didn't have to pay the fine, you received your certificate, which would erase the infraction, and your insurance insurance carrier was never notified.

However, times have changed. The Court can still recommend that you attend Traffic School, (or, again, you may request it), If you decline, your insurance carrier will be notified, which will, of course, have a negative impact on your insurance rates, and there will be points against your driving record. Either way, there will be a hefty fine. However, once you pay the fine and successfully complete traffic school, your citation will be erased from your record and your insurance company will be none-the-wiser. According to California Vehicle Code Section 1808.7, only one citation in an eighteen (18) month period can be masked from your driving record through driving school participation. The eighteen (18) month period is calculated from the citation/violation date, not class attendance date.

To attend traffic school, both the citation bail amount and a non-refundable administrative fee must be paid before you can enroll. The traffic school will charge you an additional fee to attend their program.

Based on statistics, drivers have become more impatient, inconsiderate, and reckless about following "the rules". Whether the increase in traffic violation fees will have a positive affect on the public's driving habits remains to be seen. However, payment of their tickets will certainly help to decrease the State's budget woes.

Editor's Note: I too suffered from "Ticket Shock". The week before Christmas, when I received my first ticket in 20 years from the Burbank PD, I knew I was dead wrong for talking on my cell phone "hands-on" as I approached a signal. But, it was a shock and an expensive lesson learned as I painfully paid \$140 for that infraction.

## **Neighborhood Council Elections:** Why Voting is Important

I have had a front row seat for much of the good work accomplished by neighborhood councils across the City of Los Angeles. Things haven't been the same since the City Charter was amended to create a citywide system of neighborhood councils to serve as advisory boards to the City Council. Their duty is to engage the public to participate in city government and serve as the eyes, ears, and mouth for citizens of their communities. Our communities are no longer held hostages by a small group of connected downtown insiders. The multitudes of neighborhoods across Los Angeles were finally invited to the party.

The years rolled by and now there are 90 certified neighborhood councils from one end of the city to the other, staffed with an army of approximately 1,600 citizen volunteers. This is grassroots democracy at its finest. People who participate have one goal in mind: improve and protect the quality of life in their neighborhoods. Neighborhood Councils in the North Valley have successfully weighed in and have made a difference on such issues as: the Las Lomas Project, Kohl's Department Store, Sunshine Canyon, The Sesnon, Oak Ridge, Marek and Station Fires, Canyon Hills Project, Home Depot, the Verdugo Hills Golf Course, Measure "B", Public Safety, the DWP, Education, Equestrian and transportation issues, and they are currently hard at work on the City of L.A.'s Budget, just to name just a few.

If you're wondering how our friends and neighbors find their way onto Boards of neighborhood councils, simply stated, you elect them. Every two years, community stakeholders across the city file the appropriate papers and run for positions on the neighborhood councils in the areas that interest them. They apply for a variety of available positions: presidents, vice presidents, secretaries, treasurers, regional representatives, and group representatives according to each Neighborhood Council's election rules. Then you go to the polls and elect those you believe are the best qualified. The winners serve on those Council Boards until the next election.

That brings me to my main point: Neighborhood council elections are taking place in regions across the city this year. In order for the system to function properly, we need you to get out there and vote. The act of voting is easy and simple, yet profound. By going to the polls and participating, you ensure that this amazing experiment in grassroots democracy continues, that it remains vibrant, and that it succeeds in your neighborhood.

During these challenging times of budgetary chaos in Los Angeles, the work of your local neighborhood councils is needed more than ever. There are fewer dollars to go around--dollars that provide the offices, personnel, and services that help the city function properly. Without a neighborhood council system that is completely alive and well, those dollars will again begin to be focused in the hands of the downtown insiders and the wealthy interests on the West Side. Basically, this matters greatly as regards to the day to day life of you and your family.

Elections for North Valley Neighborhood Councils in Region A will take place on March 2, and for Region B on March 27. Check the Neighborhood Council page in this issue of the NVR for your Neighborhood Council's election location, date and time.

Al Abrams, Vice President- Board of Neighborhood Commissioners, said, "The Mayor has not specifically made clear whether he intends to abide by Section 514 of the Charter as it relates to his decision to transfer one or more of the duties and functions of DONE to the CDD. Section 514 mandates that any transfer of the powers, duties, and functions of DONE (a Charter created department) first be presented to the City Council for approval, modification, or rejection by a two-thirds vote during a 45-day consideration period. The submittal must be very detailed and include copies of all proposed ordinance(s) needed to effectuate the proposed transfer of powers, duties, or responsibilities. The Council's failure to timely act on the Mayor's proposal is sufficient to allow its terms to go into effect." Now is the time for neighborhood councils across the city to ask questions about the possible merger of DONE with the CDD. Will the new department be DONE/CDD or CDD/DONE?

In a recent article, attorney Noel Weiss wrote, "If the Mayor continues to ignore his responsibilities under the Charter, and unlawfully attempts to consolidate power into his office, the chances of the City's bankruptcy are enhanced, not diminished. We cannot afford to have a constitutional crisis on top of a budget and economic crisis."

The fate of the 90 NCs remains up in the air. Many have expressed concerns that more funding slashes would create hardship for NC operations which includes community improvement and outreach.

In her letter to the City Council, Barbara Monahan Burke, Studio City NC, said, "Neighborhood Council funding was already reduced by \$5,000 this year. A reduction of an additional 50% is a far greater reduction than many city departments are being requested to make. More and more expenses are required to be paid for by the Neighborhood Councils, i.e.; election outreach, which was expected to be paid for by the City Clerk's Office. The value received from the Neighborhood Council system far exceeds the cost of its allotted budget."

But Krekorian remains optimistic in his fight to preserve NC's. "We all acknowledge the need for important cost cutting measures, but we cannot allow cutbacks to gut the very successful system of Neighborhood Councils," said Krekorian,. "Neighborhood councils are a vital tool to empower communities across Los Angeles and I am unwilling to limit their voice. We must not balance our budget on the backs of neighborhood council members, most of whom serve an essential role in our communities' growth."

The committee asked that the city study the feasibility of neighborhood councils controlling their elections, instead of the City Clerk, for the 2012 NC election cycle. Little Landers Historical Society in Sunland-Tujunga is using modern electronics to preserve history. ## **Proposed Bill to Protect Teens Who Abuse Alcohol**

State Assemblymember, Anthony Portantino, introduced AB 1999 in order to encourage teenagers to seek emergency response when a fellow teen is in need of medical attention. The bill would offer limited immunity for the teen reporting the incident, and as a result may cause more incident reports. However, net results might lead to saving lives.

The Bill would protect an underage drinker, or one or two peers who seek emergency medical attention due to alcohol poisoning, by granting them immunity from criminal prosecution. The immunity could only be granted to the victim and the one or two underage peers acting in concert if they are the original callers and stay at the scene until the authorities arrive. His Bill is modeled after similar legislation from other states whose experiences show that this approach does not encourage or condone underage drinking. Instead, it creates a situation where a child in need gets the medical help he or she warrants. According to Assemblymember Portantino, "What it does is decrease barriers for young people who need emergency medical care, but are scared to call because they made a mistake."

## **Students Tip Their Hats** ...and Pockets to Haiti



On the heels of the devastating earthquake and widespread suffering in Haiti, Hillcrest Christian School students felt a strong desire and obligation to make a difference in the region. Two student-initiated fundraisers, "Hats for Haiti" and "Change for Haiti", spurred a one-week-long drive to collect money for the cause. ## I'm Hard at Work on the Budget

As you all know, Los Angeles is facing a tremendous budgetary challenge right now, with multiple city services endangered and thou-

sands of city employees worried about their future. The City Council continues to consider a range of options to begin to bridge our deficit and get L.A. back on the long road to fiscal sustainability.

Personally, I have called for greater efficiencies in, and increased enforcement of debt collection. We need to recover what is owed to the city, and I will press city officials until we recoup those funds. Deadbeats, scofflaws and tax cheats shouldn't get away with refusing to pay up as our crisis worsens.

Additionally, I have directed my staff in City Hall to look into other alternative measures to solve the city's budget mess by reducing our costs. At the same time, my district staff continues to address your needs in the most efficient and effective manner possible.

I also asked our city's financial office to analyze the impacts of raising the city's transit occupancy tax, which out-of-town visitors pay at hotels. A modest increase in the hotel tax would not affect local residents, would have no impact on tourism and would help us bridge our ballooning deficit. It would also save city services by bringing in tens of millions of dollars from outside Los Angeles.

Los Angeles faces a projected \$212 million budget shortfall this fiscal year, and a \$484 million projected shortfall for Fiscal Year 2010-11. A relatively high unemployment rate in the city (about 15% - well above the national average of 9.3%), declining home values and plummeting tax revenues have created the perfect storm of fiscal collapse.

The last time L.A. experienced a recessionary period was in the early 1990s. That economic lag lasted a relatively brief eight months (from July 1990 to May 1991), but the city's general fund tax revenues did not return to pre-recessionary levels until 1997. Because of the extraordinary depth and length of the current recession, the city's revenue base could take much longer to recover this time around.

Economists and analysts say that the worst of the recession is over, but in the real world the pain for many of us has yet to fully subside. No one knows how long it will take us to recover from our current recession, though we should assume that it will take a number of years and the city should prepare accordingly.

In the coming days and weeks, I will try to provide as much transparency and straight talk as I can about this process. I will do my best to keep you fully informed, to dispel false rumors, and to reach out to the residents of our district for input and engagement.



## The Never-ending Budget Story

City officials for years have ignored the fact that spending more money than they take in sooner or later leads to bankruptcy. They did it in good times and in bad, and they are still doing it in this time of the worst

economic decline since the Great Depression.

Fifteen months ago, the city's financial advisers laid out the case that drastic measures needed to be taken at once. Their advice was ignored and every quarter since then, city revenues have fallen by double-digit percentages. Yet, the mayor and the City Council kept on spending like there never would be a day of reckoning.

Finally, in June, without any financial analysis, they cut a deal with most city unions to pay 2,400 workers handsome bonuses to retire early. When that deal blew up and was shown to make the city's financial situation even worse, they went back to the bargaining table and cut a second deal that involved workers paying a little more toward their pension, and giving up pay raises for two years with the promise of being made whole within five years.

Now that deal has blow up as financially unsound, too, so we are watching the mayor and Council doing a budget contortionist act to try to get the unions back to the bargaining table a third time.

They gave the unions all the leverage back in October when they signed the last deal so we have seen in a matter of days of the threat of 1,000 layoffs jump to 2,000, and then 3,000, and finally, now 4,000 --- the exact number that was in their financial advisers' report 15 months ago.

If layoffs are ever carried out, it will mean the overall city work force will have been reduced by nearly 7,000, or close to 15 percent of the total. But all the cuts proposed come from a pool of less than 13,000 workers – the people who run the parks and libraries, community planning and building code enforcement, and many other services used by all of us

The truth is, they do not have a plan to fix what is broken--what they broke. Their only plan is to get through this year, and maybe next, by selling off golf courses, parking structures, the convention center and other revenue producing assets, to defer costs into future years and to borrow heavily – all steps that perpetuate today's problems for years, even decades to come.

It is a never-ending story.

The moves they are making will blow up, just as surely as the ones they already have taken.

Dramatically worse services hurt the quality of everyone's life, the value of everyone's property and business. Dramatically higher DWP rates coming as soon as April 1, and higher fees for just about everything in the city hurt everyone, drain money from the economy, and make life harder at a time when incomes are declining and jobs are in jeopardy.

All that their strategy achieves is to get through this year and maybe next. They have no plan beyond when the deficit is expected to reach \$775 million, or nearly 20 percent of the current budget, or the year after when it goes past the \$1 billion mark. This is a catastrophe in the making. Every action they are taking is certain to blow up into controversy and conflict without actually solving the problem.

But it doesn't have to be this way. There is only one

way out that preserves city jobs and services, and cleans up the city's financial problems once and for all. Instead of using gimmicks and deceits as the city's leadership is doing, they need to admit they have failed. They need to bring the civic, business, labor and community leaders to the table and talk about how we all pull together to save our city. Clearly, city workers at all levels including agencies such as the DWP are paid more than we can afford and their pensions and health benefits are too extravagant. The unions need to take a step back financially to scale payroll costs to revenue. They won't do that unless there is real job security and a commitment from the public to pay a share of the cost of fixing the city's financial mess.

A short-term tax of some sort on sales or property combined with reduced payroll costs could right the ship of the city and preserve the quality of our lives and our hopes for the future. Power sharing itself would change the city's political dynamics and actually give us the chance to do a better job of managing our affairs for success as partners instead of as victims of a political machine that has lost the confidence of all sectors of the city. There is no other way.

## **DONE: An Appendix for the Community Development Department?**

Deputy Mayor Larry Frank presented on Feb. 23rd at a Board of Neighborhood Commissioners (BONC) meeting, the organizational structure for the Mayor's plan to merge the Department of Neighborhood Empowerment into the Community Development Department (CDD). Merging eliminates DONE as a separate and distinct department and replaces it with an Office of Neighborhood Council Support making it merely a minor appendage to the much larger CDD.

It's not just that the new, tiny 16 employee office is small, compared to CDD at 300 employees, it's trouble-some because it will not be an independent voice for neighborhood councils, but will answer to the Assistant General Manager of CDD. That's right the new Director of Neighborhood Council Support (née DONE) and BONC as well will be UNDER the AGM at the CDD. [NOTE: Larry Frank, no doubt under pressure, moved BONC out from under the AGM to under the General Manager directly]

To add insult to injury the CDD General Manager publicly at last week's (Feb. 16th) City Council Education & Neighborhoods meeting expressed no desire to have DONE part of his department, something that Larry

Frank and the Mayor would have know before the plan was made public.

So we have a reluctant shotgun marriage forced by the Mayor.

What makes the plan DOA (dead on arrival) for me (and probably the City Council) is that the CDD General Manager will actually select the DONE Director.

No longer will DONE be headed by a candidate selected by the Mayor and confirmed by the City Council.

With every council district having several NCs, I would think that every Council Member would be against that part of the plan at least.

Since structure is everything in an organization, will DONE have to be satisfied with whatever resources and hand me downs it can get from the CDD?

Although I can see some synergy between DONE and CDD on outreach for some important community programs, more likely though DONE will get marching orders to assist CDD in areas and directions that neighborhood councils do not want to go. Money and resources that should be used to improve L.A.'s neighborhoods could be largely consumed by CDD's mission.

Some say it is possible for DONE to continue to exist as an independent department the way the voters decided and still cut as many positions and dollars as the mayor's consolidation plan anticipates. Even if it turns out to be legal, having a commission and a department that were created by the City Charter reporting directly to an assistant general manager in a department that is created by ordinance is simply a bad idea.

Neighborhood Councils were set up to be an independent community voice, not carry water for the City Council or Mayor and not certainly for the Community Development Department.

This revelation is much more serious and far reaching than losing rollover funds or having delayed NC elections, far more serious than reduced NC funding. The Mayor's plan in contrast, stabs a stake into the very heart of the NC system. If this subservient role is enshrined in the City Charter and by ordinance neighborhood councils may not have access to resources they need and could be subject to unfriendly directives and maneuvered in directions not of their choosing – by both the CDD and the City Council. The sentiment of some in the City to minimize the pesky NCs will have been realized.

The Board of Neighborhood Commissioners made no recommendation to the City Council, wanting to study the proposal in more detail.

The Education and Neighborhoods Committee will take up the issue at their next meeting on March 9th.

This meeting is crucial to our survival.

## **How State Budget Cuts Affect LA County Safety**



Los Angeles County Sheriff, Leroy Bacca,

In a letter recently released by Los Angeles County Sheriff, Leroy Bacca, he noted the serious negative impact proposed cuts will have on public safety. State, County and local governments are looking at another year of reduced budgets and additional costs.

According to Baca, Legislators wrote and

passed Senate Bill 18 (SBX3 18) which took effect January 25, 2010. The measure was written as a way for the California Dept. of Corrections and Rehabilitation (CDCR) to decrease its budget by decreasing the time sentenced inmates serve in prison, and increasing sentencing credits for jail and prison inmates. Also, certain prisoners who would normally be released to a parole agent on a "supervised parole" with a detailed program of re-entry, would be placed on "summary parole", which is another way of saying "unsupervised parole".

CDCR is currently reviewing over 7,000 Los Angeles County parolees. When releases occur, the offenders will be unsupervised, released without a plan

or program for proper, safe re-entry into our communities and without accountability. The Sheriff's Department is working together with the Board of Supervisors, various county public health and human services departments, and other local law enforcement agencies attempting to reach out to the parolees. It doesn't replace supervised parole, but at least that lets them know about available services that can help and support their needs, said Baca.

Unfortunately, the state's 2010-11 budget and Federal Court Panel's mandate will now shift the responsibility of some "felony" inmates to the county jail system, which would have an immediate affect on local community safety. Under the budget proposal, there are at least 11 current crimes for which a person could be convicted of a felony and sent to state prison. They include crimes such as grand theft, receiving stolen property, possession of methamphetatamine and auto theft, which would be changed to an "administrative felony". That person would still be convicted of a felony, but he or she would be sentenced to 366 days and placed in the county jail

While this creates savings for the state, according to Sheriff Baca, "it is irresponsible to shift the costs to counties. The Los Angeles County jail system is already a severely overcrowded system that has population controls placed on it by the federal court. If the Governor's proposal were, in fact, to become law as

of today, this would mean the Los Angels County Jail would have to house approximately 1,900 additional inmates who would currently be sentenced to state prison. Since we are already at capacity, this would force me to comply with the federal court order to reduce the amount of time some inmates spend in jail to a fraction of what they were sentenced to. Again, the state's proposal clearly shifts the state problem onto counties and local communities."

He went on to say, "I am increasingly concerned about proposals related to parole, county jails and increased local responsibility at a time when we are struggling to fund and manage our current responsibilities and inmate populations. We urge careful scrutiny of these proposals and that the Governor and legislature weigh fiscal benefit against public safety impact before making further changes this year."
