Assembly Bill 1581 Goes Down...for Now

Sacramento - California State Assembly Bill 1581 in the morning of Tuesday, August 31, appeared to give a green light to developers of big box retail stores in any area of their choosing, and they would be able to by-pass many CEQA requirements as well as eliminate input from affected communities. According to Assemblymember Cameron Smyth's office on Tuesday morning, the entire Assembly had passed that bill, but it had also been sent back to committee to refine environmental issues. Smyth's office said Smyth supported it because it creates jobs. His office referenced the Costco and Best Buy Stores that are in the former Price Psfister Manufacturing plant, which is in an industrial area in Pacoima, not a commercial/residential neighborhood that many of these types of big box stores prefer. They reported that the bill would be moving on to the Senate in about a week for their ratification.

According to Abby Diamond, Secretary of the Sunland-Tujunga Alliance that specializes in land use issues, her understanding is this amendment to the original AB 1581 would have completely erased the original intent of the bill and eliminate any public review for large retail projects. She said, "That is a terrifying last minute back door move to erode CEQA. Jobs should follow good planning, which is based on existing land use and zone regulations. Jobs should not be the basis for changing land use zoning. According to Jim Summers, Past President of Granada Hills South Neighborhood Council and Old Granada Hills Residents Group, "big box stores do not necessary bring in good jobs compared to other types of businesses. This Bill's amendment seems to reek of special developer influence versus quality of life in neighborhoods. There is no reason that developers and community members cannot work together with a little effort. What this really would really do is circumvent community input to local projects that permanently affect the quality of life in our neighborhoods."

The following email was received Tuesday afternoon from Assemblymember Smyth in answer to an email sent to him on August 30. "AB 1581 originally dealt with Recycling Market Development Zones when it was in the Assembly, where it passed with a unanimous vote. A few weeks ago the author gutted the contents of the bill and replaced it with the new language you are opposed to dealing with the California Environmental Quality Act (CEQA). At this time I have not yet had the opportunity to vote on AB 1581 in its new form.

The legislation will come back to the Assembly for concurrence, giving me the opportunity to vote on the new language. I understand your concerns and opposition to AB 1581, and will take them into consideration as I decide how to cast my vote. Along with your views, I will also consider the needs of the economy throughout my district as well as the entire state in deciding whether this policy would be beneficial." However, a stunning unexpected change of events took place in the Legislature late Tuesday night when the bill was e killed, as reported by Karen de Sá with Mercury News.

"Perhaps no defeat was more surprising than the fate of a bill crafted and pushed by lobbyists for Wal-Mart. The bill, which would have waived environmental review for retailers moving into vacant stores, appeared on Monday to be headed for passage.

Several legislative sources said the defeat of AB 1581 came after the Mercury News reported on the bill Monday as another example of how private interests have hijacked lawmaking in California. The paper earlier this summer reported that more than one-third of all bills in Sacramento have outside "sponsors" and that bills with private-interest sponsors are twice as likely to pass as those written by lawmakers and their staff. But attorney Doug Carstens, a Santa Monica environmental law expert, was reluctant to declare victory after the defeat of the Wal-Mart bill, which backers had said would get businesses up and running faster in a recession-heavy state." It just means that this time the public won," Carstens said. But the next time - who knows?"

State Senator George Runner, responding to an inquiry from Sunland-Tujunga Land Use Committee member Elaine Brown, said "since the bill failed to pass the Legislature, it would not be eligible to be introduced again until January 2011."







Watering Days Expanded - Changes to the City of Los Angeles' Water Conservation Ordinance are now in effect for Los Angeles City residents and businesses. Customers with sprinklers can water three days per week. Customers whose street addresses end with an odd number can use their sprinkler systems on Mondays, Wednesdays and Fridays. Customers with addresses ending in even numbers can water on Tuesdays, Thursdays and Sundays. Addresses ending in fractions are treated as whole numbers and observe the same day restrictions as others on their same side of the street, (i.e.: 4321 _ is regarded as 4321, an oddnumbered address. L.A. City Planning Department - has a new Planning Director. Michael LoGrande has been confirmed by the City Council. LoGrande, the previous Chief Zoning Administrator for the City, officially takes office on Sept. 1. He plans to attend several upcoming community meetings in the near future. The Department has released a staff report and proposed ordinance regarding Core Findings. This document is intended to update common findings for conditional uses, adjustments, and other quasi-judicial land use approvals to provide better framework for analyzing the merits of proposed development projects and eliminate redundancy in case processing. Neighborhood Council Land Use Committees will be reviewing these proposed changes and providing feedback to the city. City Planning has also released Citywide Urban Design Guidelines for Commercial, Residential (Multi-Family) and Industrial uses. The guidelines are expected to be "just guidelines". Development proposed for Mission Hills - at 10635 Woodman Ave. St. Ephraim Syriac Orthodox Church is proposing and requesting a Conditional Use permit to construct a church compound with multi level buildings ranging from 26 feet to a 55 foot bell tower consisting of a two story church; chapel; fellowship hall; multi-purpose room; offices; administration rooms; library and a Bishop's residence. They are also requesting a Zone Variance to allow for a two story, 23,000 square foot apartment building for senior citizen residents with 28 one bedroom rental units. Total proposed developed floor area: 72,250 square feet. Off street parking will be in accordance with the Los Angeles Municipal Code and will provide 288 parking spaces. Bill to aid Community College Students is passing - Senate Bill 1440, authored by State Senator Alex Padilla, is waiting for the Governor's signature and, according to Padilla, it will prohibit community colleges from requiring students to complete more credits than is required by Cal State Universities to receive transfer degrees. It will guarantee students with a transfer degree CSU admission and junior status by creating a clear and concise pathway for Community College students seeking to transfer to a four-year university. He also said it will better align our higher education system, saving students time, money and freeing up state resources to serve more students. SB 1440 would require California's Community Colleges to create degrees for transfer to a California State University (CSU). The bill would preclude community colleges from requiring additional courses for this degree. Those barriers frustrated and discouraged students and added expense to students as well as inefficiency to the college system.

A Lawsuit against Lopez Canyon Truck Driving Academy - has the blessing of County Supervisor Michael Antonovich. He says, "Operating a trucking school where diesel tractor rigs will be spewing exhaust on property that is designated as open space is wrong. He is in favor of the lawsuit filed by community and resident groups to reverse the City of Los Angeles approval of a truck-driving academy in Lopez Canyon. The Los Angeles City Council -- rejecting a dozen more suitable locations suggested by residents, unanimously approved the site ignoring massive opposition from more than a dozen civic associations, environmental organiza-

On Tuesday, August 3, 2010, Operations-Valley Bureau kicked off the "Lock It, Hide It, Keep It"

campaign from its Headquarters at 7870 Nollan Place in Panorama City. Deputy Chief Kirk Albanese provided statistics from the first six months of 2010, that clearly identified Burglary Theft from Vehicle (BTFV) and Burglary from Motor Vehicle (BFMV) as a problem in the San Fernando Valley. " The irony is that if folks would take a few extra seconds to properly store their belongings, this crime could be eliminated. There is no good reason to be the victim of a BTFV or BFMV," said Albanese. The average cost of a BTFV to each victim is roughly \$1,885.00.

In February 2010, Deputy Chief Albanese recognized the high incidents of property crimes throughout the San Fernando Valley and directed crime reduction strategies on those crimes. One of the most effective strategies in apprehending criminals involved in auto related crimes is the use of the Valley Crime Task Force Bait Car. A Video taken during actual Bait Car Sting Operations were shown at the news conference and can be viewed on the Department's website at <www.lapdonline.org>. The video is evidence that objects left in plain sight, in unlocked vehicles, are a crime of opportunity for many criminals. Roger W. Toth

Earlier this month, I stood before the North Valley Area Planning Commission and urged them to oppose plans for a propane filling sta-

tion on Foothill Boulevard. I was very pleased when the commission agreed with me - and the community - that the proposal would be out of place for the neighborhood and potentially dangerous for the community.

In the end, the commission sharply reduced the size of the proposed propane tank to a mere shadow of its original size: from 25 feet by five feet to just five feet by five feet, a whopping 80% reduction.

We need jobs and business development in the North Valley and, as vice-chair of the committee that is charged with stimulating the economy; I take that role very seriously. However, while the lot in question could potentially be an important center of commerce on a thoroughfare in need of robust economic development, these plans were not right for Sunland-Tujunga and would not contribute to the badly needed revitalization of Foothill Boulevard. I did not come to this opinion quickly. My office attended numerous community meetings and weighed the merits of each side, as I do with all proposals that cross my desk.

I also considered the existing regulations that govern development along Foothill Boulevard. According to the Foothill Corridor Specific Plan, all projects must "create a vibrant commercial environment along Foothill Boulevard... by encouraging appropriate uses" that compliment the surrounding community. As I testified to the commission, this project is wholly incompatible with the stated intent of the specific plan to create a vibrant, community-oriented commercial corridor. That is why, after extensive outreach and careful deliberation, I unequivocally offered my full support to the Sunland-Tujunga Alliance and joined them and others in the community in opposition to this project. I congratulate all those who worked so hard on this issue and I look forward to working with the community in encouraging more economic development in Sunland-Tujunga and the rest of the City of Los Angeles.
