Padre Margil, after finding the boy with tears in his eyes, assured Shavano that a gift is only a token that we give to show our love. Shavano wasn't convinced, and wanted to give gifts of gold and objects of wealth as the other villagers had done.

He once again retreated to his poplar tree. After a while, he looked down to see an unusual bright wisp of green on the ground below. He climbed down to inspect the place and found a small plant, one so tiny that it could have been trampled without notice. The boy dug up the small plant, placed in it one of his mother's earthenware jugs and shyly hid it beneath the expensive and colorful gifts near the manger in the mission chapel.

Early the next morning the Christmas pageant was begun. Shavano worried that the Christ child would be displeased with his insignificant gift. As the pageant procession began, and the shepherds in the play approached the doorway, they gasped in surprise, then cried, "Milagro, Milagro!" Miracle!

Shavano wormed his way to the front of the group wondering what blessing the Christ child may have bestowed on the people. Before the door he stopped, his whole being quivered with ecstasy and his eyes filled with tears of joy. His little vine had grown mysteriously, had twined itself about and over the manger where the Jesus babe lay and had poured over the scene an abundance of bright green leaves and brilliant scarlet berries. The vine had become the most beautiful gift of all, even more beautiful than the gold and gifts of wealth. The Margil vine still grows in that Texas area and is enjoyed as Christmas decoration by Mexicans today.

Whether our memories are of Posadas, fiestas, prayers, decorations, lavish gifting, a military outpost, a prison cell, or a lonely room, Christmas season means much to all faiths and those of all beliefs. Let us once more petition for the gift of love, pray once again, and again, for the gifts of peace and good will toward one another in honor of The True Spirit of Christmas.

# Arleta 30-Year Dream Comes True

Al Piantanida, founder of the Arleta Watch Dogs, moved to Arleta in the summer of 1984. The first thing he noticed was all the blight in the northeast San Fernando Valley. He made a pact with himself that he would do everything he could to make Arleta the center piece of the northeast San Fernando Valley.

Over the past decades, he has been involved in many improvements that have taken place in Arleta, such as: the closing of many bars with the problems that they caused; supporting many new sewer projects; working with the LAPD, forcing gangs to leave the area; and helping with community support in the building of Arleta High School.

Al has also involved himself with supporting improvements in the Los Angeles City Service Departments, such as street sweeping, adding more streets each year, more street and alley lighting for a safer community, miles of roadway resurfacing, sidewalk repair and replacement. He is involved in many Community Clean-Ups for Green, Clean & Save Community.

Al's dream for many years has been to upgrade and see new parks and walking paths built here and in the surrounding area for the healthcare of their children and their families

Then-Councilmember, Tony Cardenas, (CD-6), asked him to become a committee member of PropkLAforkids Project, which funds projects for five city council districts in the San Fernando Valley.

He did represent Council District 6, which received project funding for major refurbishing of Branford Park, walking paths, total remake of all baseball diamonds and sports fields. Also included was a new skate board park serving the Sun Valley-Arleta area, with the most modern design available, and is the largest in the City of Los Angeles.



Now, after 30 years of waiting, the final piece is in place for Al's dream to finally come true. Just two blocks from his home, the large vacant lot on Arleta Ave. where it meets Devonshire, which has been designated for a park for so many years, is a vacant lot no more.

The Grand Opening of the new, "Devonshire/Arleta Park" finally took place in May of this year.

## Sunland-Tujunga Local Grass-Roots Organization Fighting Canyon Homes Development Project

In response to a 242-home development project being proposed next to the Angeles National Forest, a group of local residents and stakeholders have banded together to fight it. "Save Our Canyon," a grassroots organization comprised of 250+ members and growing, has launched a campaign called "Stop the Canyon Park Development" on Facebook and YouTube. The group, just four months old, has already received support from the Sunland-Tujunga Neighborhood Council and its Land Use Committee (LUC) to comment on anticipated re-zoning application for the property at 12400 Big Tujunga Canyon Rd. The LUC also decided to submit a Community Impact Statement and request that a full scope Environmental Impact Report (EIR) be required. The up-zoning application, if approved, would reverse a 2007 General Plan Amendment which down-zoned the property and surrounding area to Minimum Residential, the lowest density possible.

Save Our Canyon's mission is to protect Big Tujunga Canyon from big development and to preserve its

rural character. Also worried about the loss of critical habitat for at least four endangered wildlife species, the organization is comprised of a broad cross-section of North East Valley stakeholders, including residents of Big Tujunga Canyon and bordering neighborhoods, Alpine Village HOA, Verdugo Hills Archery

Club, environmentalists, and equestrians worried about the potential loss of trails.

If approved, Save Our Canyon believes this large-scale development project, slated for construction in an environmentally sensitive watershed, would forever change the pastoral character and tranquility of our Gateway to the Angeles National Forest.

## San Fernando Valley's First Science Museum Opens

After more than a decade of delays and financial uncertainty, the Valley's first science museum finally opened to the public on November 13th.

Located in Lake View Terrace on 2.5 acres of land in the Hansen Dam Recreation Area, the two-story Discovery Cube Los Angeles is a \$56 million project featuring 71,000 square feet of hands-on science-based exhibits, displays and learning spaces.

The grand opening was an impressive hour-long ceremony with congratulatory speeches by those involved with making the museum dream a reality. Afterwards, the dignitaries gathered on the stage at their assigned power stations and a group photo was taken of the entire audience. And then on queue, they began pushing levers, turning wheels, and pulling ropes to "power up" the centerpiece needle which moved from "inspire" to "educate" and finally to "impact," setting off fireworks and confetti. And with that, the facility was opened and hundreds of science fans of all ages streamed into the museum for the first time.

Visitors explored distant galaxies and dinosaurs, took a helicopter tour of Southern California, shopped for sustainable groceries in a miniature market, and descended deep below the earth's crust to help save water and protect the aquifer without ever leaving the San Fernando Valley.

The museum was inspired by the 25-year success of Discovery Cube Orange, formerly the Discovery Science Center, which is undergoing its own expansion under the newly formed Discovery Science Foundation (DSF).

The two Discovery Cubes are part of an ongoing commitment by the DSF to expand STEM (Science, Technology, Engineering and Math) proficiency, early childhood learning, healthy living and environmental stewardship in Southern California through engaging science-based programs, and exhibits that create a meaningful impact on the communities they serve.


Permanent, hands-on exhibits spotlight the work of the City of Los Angeles Bureau of Sanitation and the Department of Water and Power as part of both groups' larger strategic partnerships with the museum. LADWP sponsored and co-sponsored exhibits are dedicated to education on sustainable housing and preserving California's valuable natural resources. The exhibits included are the Inspector Training Course, a simulated Helicopter Tour, and the first-ever "Aquavator" – a virtual elevator that takes guests down into earth's crust to learn about aquifers and how to protect these fragile, underground reservoirs. Visitors learn about the different types of aquifers, how aquifers are beneficial, and why they are important to the local environment.

"Education is critical to the success of our efforts to transform Los Angeles' water and power supplies and create a more sustainable future," said LADWP General Manager Marcie Edwards. "LADWP is proud to sponsor exhibits at DCLA that creatively illustrate what it takes to get water and power to Los Angeles. Through this, we can engage Angelenos of all ages in protecting and conserving LA's water and energy resources."

The Bureau of Sanitation (LA SAN) is represented by sponsored and co-sponsored exhibits dedicated to teaching visitors about waste reduction and resource conservation. These exhibits include the Discovery Market, Planetary Research Station, Inspector Training Course, Aquavator, and the "Race to Zero Waste" – a thrilling, game-based adventure that challenges participants to sort trash and divert materials from landfills. Players learn what items can be recycled, qualify as green yard trimmings, and what should be disposed at S.A.F.E. (solvents, automotive, flammables, electronics) Centers.

"L.A. Sanitation is proud to partner with Discovery Cube Los Angeles to inspire, educate and impact sustainable practices to promote quality of life and protect public health and the environment," said Enrique C. Zaldivar, director, City of Los Angeles Bureau of Sanitation. "These state-of-the-art interactive exhibits will send DCLA visitors home with the tools to get involved and be environmental stewards in their own neighborhoods."

Discovery Cube Los Angeles features the following permanent offerings: multi-video adventure. Guests will follow the 300 mile journey water travels

from Mt. Whitney through the Los Angeles Aqueduct system and into the L.A. basin, while learning about the scarcity of water and how conservation can protect this precious natural resource. Then, a second video explores the process of water sanitation and reclamation with an underground view of local sewer systems and the Tillman Water Reclamation Plant. Guests will learn what happens to water after it's been drained, flushed, and used, and how treated water can be repurposed in the community.

- Helicopter Adventure Step into a one-of-a-kind helicopter theater and lift-off on this multi-video adventure. with an underground view of local sewer systems and the Tillman Water Reclamation Plant. Guests will learn what happens to water after it's been drained, flushed, and used and how treated water can be repurposed in the community.
- Discovery Market An immersive grocery store that uses game-based technology to teach kids and their parents the importance of purchasing and packaging decisions as well as labels, nutrition facts, and making healthy shopping choices. Based on one of the most popular exhibits in Orange County, DCLA's version will be updated and customized to Los Angeles.
- Sun Stage DCLA staff lead live, hands-on science demonstrations that use fun games, audience participation, and guest interaction to educate and entertain.
- Planetary Research Station Examine Earth like never before using a suspended, animated globe.
   Visitors will have a unique view to observe visuals related to the atmosphere, oceans, and land.

With a focus on climate change, visitors can explore weather patterns and watch historic storms, observe the impact of catastrophic earthquakes and human activities, and gain an understanding of global warming along with flight patterns, and all from an out-of-this-world perspective.

- Making the Grade Gallery A customized gallery that brings grade-specific lessons to life through hands-on exhibits to help students throughout Los Angeles County better understand the Next Generation Science Standards.
- Inspector Training Course Visitors will master their skills in resource efficiency and sustainable housing choices when they become eco-friendly home inspectors during the Inspector Training Course. Touch screen tablets will teach ways to employ the four R's reduce, reuse, recycle, recover; conserve water, energy, waste; and even offer tips for earthquake preparedness.
- Park Science Learn about the environment surrounding the Hansen Dam area and the importance of exercise with rock climbing and mountain biking. Take a lesson in meteorology and learn about the Santa Ana winds, the L.A. River, local habitats, and tree science.
- School Readiness Gallery It's never too early to start preparing for kindergarten. Early learners will find activities to help build skills necessary for reading, understanding language, understanding the concept of numbers, and to succeed in school.





## Legislators Think Silence is Golden

Ladies and gentlemen, the following are reasons why I supported candidate Patty Lopez for our Assembly in Sacramento: For many years we have been deceived by a coalition of elected officials who are supposed to represent our best interests in our communities. But, apparently, their ideas are instead focused on first,

being re-elected, placing their political party ahead of their constituents needs, growing their support base by giving taxpayer grants to selected nonprofit organizations, and promoting slogans with catchy names that often just raise our taxes and fees, which really only benefit their special interests groups who contribute thousands, tens of thousands, and even millions of dollars to their campaigns in exchange for favors.

To the rest of us, including the record high number of unemployed residents, it seems that we only see our elected officials for ribbon cutting ceremonies, group photo opportunities when officials appear for a Saturday morning cleanup day, parades, and occasionally an appearance at a community meeting to promote a new program that ends up increasing our taxes or fees.

But, when we want to express our concerns about neglected city services that we've paid into, or ask for funding for education or the arts or express our opposition to increased taxes, officials do not seem to hear us.

An example of silence from elected officials is the \$40 million ratepayer dollars, transferred over the years into two secret DWP union accounts, and the effort of our City Controller, who is demanding answers from the DWP union leader by using subpoenas to determine if any wrong doing is involved in these two secret accounts.

Our city council, which sets policy for multiple city departments, is being silent about this matter, when Councilman Felipe Fuentes, who chairs the Energy and Environment committee, should be leading the charge, the investigation, and taking control of the situation on behalf of DWP ratepayer customers.

Another example of silence is Senate Bill 1, (SB1), Sustainable Community Investment Authority, which is on hold. It was authored by former Senator Darrell Steinberg and signed and supported by Assemblyman, Raul Bocanegra. Our past elected officials and Ms. Patty Lopez's opponent, Assemblyman Bocanegra, apparently have made no attempt to inform their constituents that they signed and voted for a law that would eliminate public comments and eliminate the voters' ability to vote on bonds being issued by SB1.

Remember, we are the Government, for and by the people. However, Sacramento legislators want to eliminate our participation in government by creating a new government agency in each county or city to grab our property taxes and by other taxes (e.g. sales tax) to finance "sustainable communities" in California. This law would allow cities, special districts and counties to create a Sustainable Community Investment Authority with no voter oversight that would drastically change our way of life. SB 1 can issue bonds without voter approval. It can declare rural and suburban areas blight without cause. It will lead to government abuse of eminent domain over private property rights. Like solar panel farms in residential neighborhoods on open space, it would lead to increase of city and county taxes. A venture like this should be left for professional private investors, not the taxpayer who will not receive any earned interest or dividends in return. It promises one thing: If we keep re-electing the same legislators who serve themselves first, instead of their constituency, then Proposition 13 will be under attack and our taxes are sure to increase at a high rate of speed.

Sacramento legislators are planning to scrape away at our Liberty and Freedom. It is very important that we oppose this kind of ideology and protect our property rights by electing those who listen to their constituents. This is why I supported and voted for Patty Lopez for the Assembly.

### What are the Most Urgent Issues Facing Los Angeles City Government?

I recently went through this exercise at a presentation by the Department of City Planning on the proposed Master Planned Development (MPD) zone, (CPC-2010-3315-CA). This is a new land use category for Los Angeles that would expedite permits for

mixed use, campus-type projects. If you are not sure what that means, imagine scaled down versions of The Grove that are at least three acres in size.

And, if you are not sure what this new zone has to do with the urgency question, it is because this the reason why this new zone is being stampeded through the city's legal adoption process and not folded into the five-year re-Code LA program. There is a backlog of 41 potential MPD projects, and – presumably – their investors want their projects to be quickly approved before market conditions change.

My first response was to review the hundreds of community meetings I have either run or attended as a city planner in Los Angeles over the past 30 plus years. I can remember many meetings where local residents expressed an interest in a supermarket, a Trader Joe's grocery store, a Target, or a Starbucks. But other than requests for public improvements, such as better street lighting and schools, this was it. Furthermore, none of these public improvements or small commercial uses requires a special new zone to be quickly pushed through the City Planning Commission and the City Council.

My second response was my own list of urgent planning-related issues. I initially included the topic I have often written about on CityWatch, the mansionization of Los Angeles, or less politely, the construction of McMansions in older neighborhoods by sleazy, profiteering real estate speculators.

But, I then realized the McMansion problem is trivial compared to the truly serious planning and planning-related issues facing Los Angeles. This is my list, and I am sure City Watch readers could add other issues that strike them as more urgent than the quick approval of MPD projects.

**Outdated General Plan.** By professional planning practice, common sense, and State of California law, every California city requires a timely and internally consistent General Plan to guide local government.

Unfortunately, most of LA's General Plan is in need of an immediate and total update. Its backbone, the General Plan Framework Element, is based on 1990 census data, was prepared in the early 1990's, and was adopted in 1996. Of the other mandatory and discretionary planning elements, only the Housing and Transportation Elements have been properly updated. Everything else is old, and some General Plan elements, like Infrastructure, are downright ancient. The City Council adopted them in the 1960's, and they have not been updated in nearly a half-century!

Monitoring. No General Plan element can be relied on if it is not regularly monitored. This monitoring process and program was built into the framework, but it has been ignored for the past 14 years. In fact, there is no functioning plan monitoring program in Los Angeles. This means that elected officials and city staff do not have current statistics for population, employment, and housing. They also have no way to know which proposed and mandated programs have been implemented and if they are effective. They have no way to know if the demand for municipal services and infrastructure has kept up with capacity. And, these just scratch the surface of what a useful General Plan monitoring program should encompass.

Traffic Congestion and Air Quality. LA's fledgling efforts at mass transit and bicycle lanes are a step in the right direction to address the country's worst traffic congestion and air quality, but just a step. To tackle these momentous problems, it is urgent that LA not just have a transportation plan, (the new Mobility Element), but well-funded implementation programs to get residents, employees, and visitors out of their cars. The means much more money for mass transit, for bicycle infrastructure, and for pedestrian improvements, especially sidewalk repairs. These projects are expensive, but they are of the highest priority, and to be truly effective they must be partnered with better land use policies. Once the transportation infrastructure is qualitatively improved, along with comparable improvements in other municipal services, the city can transition to higher densities. If higher density is encouraged—as is the current practice—without adequate transportation capacity, recreation and parks, schools, libraries, public safety, animal regulation, and a host of other categories, Los Angeles will experience a relentless downward spiral of urban decay. Shiny new luxury apartments, office buildings,

McBoxes, and shopping malls – even if rapidly approved as MPD projects – are hardly enough.

Seismic Safety. We live in earthquake country, and the "Big One," an earthquake much larger than the 6.7 Northridge earthquake, (1994), is certain. Yet, the active earthquake faults have not been properly identified, and the list of extremely vulnerable older buildings UC Berkeley engineers predict will fail in a large earthquake has not been made public. Furthermore, unlike San Francisco, Los Angeles does not yet have an actual program to retrofit these structures so they can withstand a massive earthquake. As a result thousands of preventable deaths and major injuries are a certainty.

**Urban Beautification.** For lack of a better word, hundreds of miles of LA's commercial, industrial, and residential streets are insufferably ugly. Drivers, passengers, bicyclists, and pedestrians must endure relentless visual pollution defined by a lack of trees, billboards, super-graphics, pole and roof signs, overhead wires, and ragged heights and building lines. Most surrounding cities, such as Culver City, Beverly Hills, Santa Monica, West Hollywood, Glendale, and Pasadena, have shown how the same climate and geography can look wonderful. This means the model is literally in front of our eyes.

Urban Forest. Of all the low hanging fruit to address many of LA's most urgent issues, planting and maintaining a vibrant urban forest, is the most obvious. True, Mayors Bradley, Villaraigosa, and Garcetti have had Million Tree campaigns, but these were largely public relations shows. They depend on volunteers, not the expertise and professional resources of the City's Urban Forestry Division. This is obviously the easiest way to literally green Los Angeles, and then reap a wide range of benefits, including carbon sequestration, recreation, habitat and water supply protection, improved pedestrian paths, passive solar heating and cooling, removing air pollutants, including Green House Gases, and neighborhood beautification. While trees may not have the same team of City Hall lobbyists promoting new shopping centers, can there be any doubt which category will most benefit Angelenos?

### "Core Values": Redefined? Part II

Common Core is like gluten: Lots of people say they want to avoid it, but they don't even know what it is. For the record, gluten is protein in grains historically used to make bread. It forms cross-links which trap carbon dioxide and that causes bread to rise. The only people who should avoid gluten are those with celiac disease.

Common Core is an educational approach to learning. It should be avoided if you are not able to think for yourself. Though some have labeled Common Core as a fad, to be sure, but nevertheless it is an attempt to correct the problems ushered in by the prior fad, "No Child Left Behind." That misguided effort did leave children behind . . . and was a great reason to keep the federal government out of education.

The impetus behind Common Core had been in progress since 1996 when the National Governors' Association and several high-profile business leaders, such as the chairman of IBM Corporation, formed a company named Achieve, Inc. The stated purpose of Achieve was to develop means to assure that a high school diploma represented a meaningful accomplishment by a young person.

By 2007, Janet Napolitano, Governor of Arizona, was chair of the National Governors' Association. She wrote an "initiative" that focused on improvement of public education in the United States. To do this, Napolitano assembled a task force of educational experts, leading business people, and governors to develop a plan. The product of the task force was the 2008 report titled "Benchmarking for Success: Ensuring U.S. Students Receive a World-Class Education." Achieve, Inc., was brought in as developer to accomplish this ambition. That is when people started taking notice of Common Core.

Backing by the Governors' Association was a logical method of promoting nationwide educational standards without the stigma that would otherwise be attached had they been developed by the federal government. It is a way of assuring that a student in Mississippi, for example, is exposed to the same topics in the same depth, at the same point in their academic career, as would a student in New York. It is a means of not only leveling the playing field, but also elevating that field to world-class loftiness. Financial backing for developing the standards came from non-government sources, notably, the Bill and Melinda Gates Foundation. And Bill Gates, of course, is the billionaire dropout entrepreneur who founded Microsoft Corporation.

The educational standards being developed focused on mathematics and English. Science curricula had its own set of movers and shakers in parallel to the Common Core proponents. Social studies teachers felt left out and complained. Eventually, they also will have standards.

"No Child Left Behind" needed to be replaced. The students were constantly being tested to gather "data." Tied to the testing was the threat that schools which did not achieve high scores on the tests, would suffer by losing operating funds, risk being taken over by other entities, and teachers being fired. So, teachers "taught to the test." If a student expected the question, "How much is 2 plus 2?" Then the teacher would teach the answer, "4," in every way possible. But if the actual test question was, "What is 3 plus 3?" The student would be lost because s/he had not been taught HOW to add in the first place! This is the problem that Common Core seeks to overcome: Students are to be taught "critical thinking" skills. How the individual states that signed on to Common Core, (45 at last count), school districts, even individual schools teach those critical thinking skills, are up to them. The point is that they be taught. This sounds like manna from heaven, What could possibly go wrong?

The answer to that question lies in the standards themselves developed for Common Core. While it is true that Common Core requires testing, and is data-driven as was, "No Child Left Behind," there is a difference. The testing focuses on understanding... but understanding as permitted by the standards. It is good that students must develop a hypothesis (called a "claim" in teacher-speak), search for evidence to support the claim, and develop a conclusion based on the evidence that validates the claim. This forces students to write, thereby improving their vocabulary, their grammar, and logical thinking skills, including structured argumentation. This is its method. But there is another part to it: The CONTENT.

Content is something that is most valued by textbook publishers. All the prior books need to be replaced with texts that follow Common Core standards, and emphasize information at the expense of classical prose. Publishers see dollar signs and they rush to pump out texts to support this "new" learning style. Electronic media is emphasized requiring that students use computers to take exams as well as to complete class assignments. Some of this "how to" knowledge is valuable and is not to be condemned. But using electronic tools is not education. It is a means to access information and obtain an education.

So, who develops the content that the students see on their tablets and laptops and smart phones? This is where many believe the core of Common Core is little more than an empty shell with minimal "core value." Critics of Common Core do not appear to differentiate between "Standards," "Method," and "Con-

tent." They look at the content and label the whole scandals involving the Internal Revenue Service tarpedagogical technique as evil. The more suspicious do dive more deeply into the inner workings of Common Core, but there they see collusion between Microsoft Corporation, Pearson Publishing Co., and the federal government. Since Common Core was ostensibly developed by private interests under the eye of the National Governors' Association, the federal connection is unclear. Unless government money is dangled in front of the state schools, "Adopt Common Core and you get the goodies!"

And with that connection, comes content written to warm a progressive bureaucrat's heart. The so-called "informational" readings would have students accept as truth various tracts written from a decidedly biased angle. There is a word for such readings - "propaganda." And that is what has conservative critics up in arms. They are not placated by bland statements of how the states are not "forced" to accept Common Core, or that they can opt out. #### Don't Leave Me!

As I lock the door and walk down the steps to my car, I see him looking at me out the window. His eyes look so sad, and I really don't want to leave but I have to."Will you ever come back for me?" his eyes say. And I drove off feeling a bit of guilt.

Sound familiar to anyone? Our world today requires that most of us go to a job, the market, the gym, etc., and leave our pets behind at home. Even though our dogs are our family we cannot take them everywhere we go, especially big dogs. As a result, some dogs get overly nervous when they are left all alone.

Dogs are social animals that form strong bonds with people, so it is not surprising that they may feel somewhat anxious when separated from their social group, meaning their human family. Most dogs adapt well to the typical daily separation from their owners. However, each dog is as unique as their paw print. Dogs act like us, learn from us, and they pick up on our personality. Are you making your dog anxious?

It is important to realize that dogs with separation anxiety are not doing these things to get even with the owner for leaving, acting this way out of boredom, or exhibiting this behavior due to lack of training. These dogs are not being destructive because they are bored. We must work each day to train our dogs to be able to entertain themselves whether we are with or without them.

The dog with separation anxiety shows signs of distress when left alone and over-attachment when the owner is present. What can you do if your dog suffers from these problems?

Do not make a big deal out of arriving or departing from home. Dogs live in the present. Although making an overly dramatic reunion with your pet may be what you want to do, it is not what will help them to cope with your absence best in the future.

Try to break the cycle of anxiety your pet experiences. Do this first with short absences. Upon re-

turning to a "normal" home, you reward your pet with praise and affection, again after ignoring them initially for 3-5 minutes. They will probably not understand this in the beginning stages, but will learn to calm down in order to be rewarded and praised by you. Repeat this several times, and they should begin to learn and expect that being "good" at home will earn its just reward.

Give your dog a chew toy like a long lasting food treat when you go out. They will associate this special treat with your departure. Your dog will have to work at removing the entire treat, so it will pleasantly occupy his/her time. Take the time to think of their needs and both of you will benefit together in the long run. I hope we can somehow convince you that the DWP's plans must be changed. The public wants renewable energy. But we want it on ROOFTOPS not in urban solar farms!
